CHARACTERISTICS OF CIVIL VALUE-SEMANTIC ORIENTATION OF YOUNG MEN AND WOMEN

This article presents results of empiric research of civil value-semantic orientation of youth. The following studies serve as theoretical and methodological basis for this research: A. Maslow's theory of personality; concepts of value orientations by M. Rokeach, S. Schwartz and W. Bilsky, D.A. Leontyev, M.S. Yanitskiy, I.G. Senin and others; the concept of problems in family upbringing by E.G. Eidemiller and V. Justickis; alongside with researches in psychology of teen and mature ages by G.S. Abramova, V.S. Mukhina, A.A. Rean, G. Craig et al. To carry out the empiric part of this research, we have applied: the Portrait Values Questionary, PVQ-RR; Social Psychological Attitudes of Personality; Life Value Orientation Test; CWO/PIL. 115 people aged between 19 and 25 took part in this research. 57 young ladies and 58 young men were selected among university students of Moscow. Specific statistically valid distinctive characteristics in the hierarchy of values among young ladies and young men were revealed. Communicative and emotional values as well as process orientation prove the most significant for the ladies. The young men prioritize status - role values, career pragmatism, material values and goal-orientation. Civil-patriotic values hold the lowest rating in the hierarchy of intensity both among young ladies and men. Results of factor analysis allowed us to characterize differences in value intensity among young ladies and men in a more convincing way. The conducted research proves blurriness and obliteration of traditional basic values and unattractiveness of civil-patriotic orientation in young people's conscience, on the one hand, and demonstrates some gender - role differences in hierarchy of value priority intensity, on the other hand.

MODERN PORTRAIT OF A TEACHER-MENTOR IN THE EDUCATIONAL SPACE OF THE UNIVERSITY

The presented research includes the results of a theoretical review and an empirical study of the psychological characteristics of the personality of a modern teacher-mentor, including those who carry out their professional activities in higher educational institutions. The study involved 104 respondents – students aged 19 to 35 years old studying at higher educational institutions

in Moscow and the Moscow region. The respondents were asked to answer questions concerning the professional sphere of modern teachers, the psychological qualities of the personality of a teacher-mentor, the definition of the very concept of «teacher-mentor», to assess the qualities, competencies, skills of a modern teacher-mentor, taking into account the priority for the formation of a psychological portrait. The assessment was carried out by the respondents on a scale from 0 to 10 points, the results of the responses were processed using statistical methods (the average value was determined). As a result of the research, six significant blocks were identified that form the psychological portrait of a modern teachermentor working in higher educational institutions: professional ethics, competence, knowledge of modern digital technologies, additional professional education in the field of psychology, creative approach to work, sense of humor. The respondents placed an important emphasis on three blocks: professional ethics, knowledge of modern digital technologies, and a sense of humor.

EXPERIENCE OF PSYCHOLOGICAL SUPPORT OF PROFESSIONAL ACTIVITIES OF TEACHERS OF ADAPTIVE SPORTS

The article presents the results of the study aimed at identifying the effectiveness of programs of psychological support of professional activities of adaptive sports teachers implemented in the State Budgetary Educational Institution «Center "Dinamika"» of the city of St. Petersburg. The study involved 28 specialists. The coaching staff represented such sports as wheelchair dancing, boccia, sledge hockey, rhythmic gymnastics. They formed an experimental group, where for one year programs of psychological support of their work activities were implemented, aimed at correcting their work motivation, improving their psychological preparation for work in inclusive groups. The control group consisted of the same number of coaches, the same gender and age. The following were studied: the level of job satisfaction and the leading motives of professional activity of the modern coaching staff working in the conditions of inclusive models of the educational and training process. It has been established that the implementation of special programs of psychological support for adaptive sports teachers working in the context of inclusive physical education helps to reorient coaches from the position of achieving high results for students in Paralympic sports to the position of providing children with special needs with assistance in their integration into society, their physical rehabilitation by organizing harmonious communication and interaction with young athletes without health restrictions, which entails an increase in the degree of their satisfaction with their professional work.

It has been revealed that the professional suitability of extreme specialists includes strength, physical training to perform tasks, impeccable somatic health, the presence of a system of professional knowledge, skills and abilities, psychological stability, the ability to work in a team, a high motivational component that requires development in the learning process.

FEATURES OF CRITICAL THINKING AS A PROFESSIONALLY IMPORTANT QUALITY OF MILITARY PERSONNEL

The article discusses the features of critical thinking of military personnel as an important professional quality. Based on the results of the pilot study, it is shown that it is one of the psychological conditions for protecting the individual from negative information and

The relevance of this study is due to significant changes in the modern information environment, its ability to influence a person's ideas about the surrounding reality, form an attitude towards it, encourage action, from which we can conclude that incompetent sources of information, or poor quality use of the media can be a threat to psychological well-being a person, his intellectual and even physical development.

APPROBATION OF THE PROGRAM OF PSYCHOLOGICAL ASSISTANCE IN THE EMPLOYMENT OF UNEMPLOYED ENGINEERING AND TECHNICAL SUBJECTS OF LABOR OF PRE-RETIREMENT AGE

The article presents data comparing the psychological state of pre-retirement age students before the start of the program and after completing the program, as well as the results of their employment. To compare the psychological state, we used psychodiagnostic techniques: life satisfaction scale; motivation to achieve success and motivation to avoid failures; anxiety scale; resilience test; locus of control. As a result of the formative experiment under the psychological assistance program, the average indicators of life satisfaction, motivation for success, and resilience in the experimental group at the end of training are significantly higher than similar indicators at the beginning of training and in the control group. The novelty of the study lies in the selection of the category of labor subjects, unemployed and people of pre-retirement age, as well as in the study of criteria for readiness for employment, and the preparation of applicants to overcome psychogenic factors at the stages of employment through their modeling. The program of psychological assistance in employment helps to overcome the difficulties of employment for unemployed people of pre-retirement age and can be used in recruitment agencies and employment services.

SOCIO-PSYCHOLOGICAL PREDICTORS OF DEFORMATION OF LEGAL RELATIONS

The purpose of the article is to analyze the socio-psychological predictors of the deformation of legal relations, which is expressed in the violation of the rights and interests of people. Ethnocentrism, xenophobia, and legal nihilism can lead to the deformation of legal relations. Ethnocentrism hinders mutual understanding and the establishment of equal relations. Xenophobia leads to prejudice and discrimination against other people, which is an act of violation of their rights and freedoms. The technology of manipulating mass and legal consciousness, denoted by the term brainwashing, is described. The technology includes four phases: 1) manipulation of the emotional components of consciousness, activation of feelings of humiliation and resentment; 2) manipulation and restructuring of public and legal consciousness, introduction of goals and values alien to culture, activation of the need for

response by actions for offenses, creation of nationalist movements, development of action programs, organization of demonstrations, protests, maidans, moral and legal justification of violence, deformation of legal relations; 3) moral legitimization of violence; 4) comprehension of the current situation. Legal nihilism, as a denial of traditional values, moral norms, and culture of the people, leads to the deformation of legal relations.

EMOTIONAL STATE AND SOCIO-PSYCHOLOGICAL ADAPTATION OF REFUGEES FROM THE WAR ZONE

The results of an empirical study of the emotional state and socio-psychological adaptation of refugees from the war zone are presented. 87 refugees participated in the study, including 18 men and 69 women aged 20 to 70 years. The main research methods were chosen: the K. Izard scale of differential emotions (SDE) in order to diagnose the dominant emotional state; the Thomas Holmes and Richard Reich stress tolerance test, necessary to characterize stress tolerance and social adaptation of the test subject; the scale of socio-psychological adaptation, developed by R. Diamond, R. Rogers (SPA), adapted by T.V. Snegireva. The study proved the existence of statistically significant relationships between the components of socio-psychological adaptation of refugees with their emotional state and needs. The results of the study can be used in the comprehensive study of refugees and the provision of differentiated psychological assistance to them.

The analysis of survey results led to recommendations for enriching similar programs and refining teaching methods based on student feedback. Implementing these findings could improve students' preparation for international language exams, enhance teaching effectiveness, boost exam outcomes, and increase student satisfaction with their educational experience.

OPTIMIZATION OF TEACHING RUSSIAN AS A FOREIGN LANGUAGE BASED ON THE USE OF SHORT FILMS

The article discusses the methodological value of audiovisual means in teaching Russian as a foreign language at level B1, an attempt is made to create a selection of the most optimal video materials (based on the topics of the texts being studied) and exercises for them. The features of the use of video materials in Russian as a foreign language classes for training types of speech activity, developing sociocultural competence and optimizing the educational process by influencing the emotional intelligence of students are analyzed. As a result, it has been proven that the use of short video materials related to the topics of the texts studied in the program significantly increases students' motivation to learn the language by generating and consolidating positive emotions, creates a favorable atmosphere, and evokes empathy in students, promoting their active involvement in the learning session.
